

Legal Notice, Privacy Policy and Terms of Use

Welcome to the VotreTransfert.com website (hereinafter referred to as "Secure", "our site", or "we" for the purposes of this document). The services offered on our site are provided by the corporation SecureDocTransit Inc., subject to the terms of use outlined below (the "terms of use"). SecureDocTransit Inc. is the sole and exclusive owner of our site and operates it independently. The domain name www.votretransfert.com is a corporate name owned by SecureDocTransit Inc., which has reserved its exclusive use.

For the purposes of this document, we will always use the term "our servers" even though we use virtual servers to operate our site.

General Information
